25-179 **WHEREAS**, the performance bond company for the Ruby Meadows Subdivision experienced bankruptcy leaving Viola Lane residents with partially complete road infrastructure that did not meet the subdivision plan and conditions of approval; and  
**WHEREAS**, Viola Lane residents expressed their desire for the Town to aid in the completion of Viola Lane to meet road acceptance standards and the Town subsequently worked with legal counsel and the bankruptcy courts which resulted in the recoupment of approximately \$45,787.20; and  
**WHEREAS**, the Town Council, at its meeting of October 8, 2024, discussed the circumstances surrounding this development and conducted a straw poll which unofficially indicated that the Council would be willing to consider accepting Viola Lane if: (1) the residents raised the additional \$55,168.40 needed to bring Viola Lane up to town standard, and (2) the residents formed a homeowners' association to manage the common elements of the subdivision, as required by § 120-911N of the Town Code; and  
**WHEREAS**, the requirement that each lot owner in the Ruby Meadows Subdivision be a member of and be subject to a homeowners' association is contained in the deed of each lot, as well as the "Declaration of Rights, Restrictions, Covenants & Easements for Ruby Meadows, A New Residential Community Located on Pope and Albion Road, Town of

Windham, Maine 04062."

**NOW, THEREFORE**, be it voted, resolved, and ordered by the Town Council of Windham, that a deadline be set for November 20, 2025 for the Ruby Meadows Homeowners Association to be legally established, and Articles of Incorporation for the same be filed with the Maine Office of the Secretary of State, to the satisfaction of the Town Attorney. Should this occur, the Windham Town Council shall vote on whether or not to accept Viola Lane as a town way on November 25, 2025. Should this not occur by the appointed date, the Town Council will not consider acceptance of Viola Lane as a town way until at least November 25, 2026, during which time, the Town of Windham may not provide any road maintenance, including winter maintenance, for Viola Lane.

*Manager Burns said it as been a little more than a year since they last met. They conducted a fair amount of work since then and almost immediately, upon the straw poll vote from October 8, 2024, the residents quickly turned in funds to augment the court/bankruptcy proceedings that the town had earned through our attorney.*

*They commenced to improve Viola Lane to the original construction standards that were laid out in the approved subdivision. Since that time the Shaw Brother's Earth Work Contractor has been onsite and has added gravel to the roadway, graded it, based paved and tied in the resident's driveways.*

*He has had several contacts with the residents and several of them are here tonight. They are now at a point where there is another number of items that need to be completed before the road can publicly accepted. The town is handling the recording of the deed. They were able to obtain the deed through the bankruptcy proceedings. They will handle the finalization of the as built plans. The proceeds from the bankruptcy process, along with the money the residents has turned in, will allow the town to create the maintenance bond for the roadway and will be able to handle the surface paving and shouldering in the next construction season. They are all lined up with the one exception of the creation of the Homeowner Association.*

*This Order basically says if they can create the Homeowner's Association by the 20th of November, then it will be on the Council's agenda for consideration of road acceptance on the 25th. If they choose not to create the Homeowner's Association, the road will remain private, at least up until November 25, 2026. He said with it being determined private, they will not be able to provide maintenance actives, no plowing of the road. He heard, via email, from three residents that they are interested in creating the association. A resident spoke up and said they are currently working on that.*

*Manager Burns said this is the result of Councilors Reiner and Morrison and himself meeting with GPCOG's staff and other Representatives, along with Speaker Fecteau. They presented to him their concerns with LD 1829, and there are several LD's they also called out. Basically, they feel the state, with the passing of this LD they have removed a number of controls the town has to guide growth in the town. The Council has worked hard on directing growth and controlling growth. This LD, in particular, strips that all away. This letter points that out. Windham has grown and we are clearly a leader in residential growth in the state with responsible growth.*

*Council Reiner wanted to make sure the completed letter was put on the town's Facebook page so the people can see it. Right now we are planning on keeping our current ordinances in effect to July 1 and to see what changes come out of Augusta, but asked how a moratorium would look if they were to put one into place?*

*Ben McCall Town Attorney said a moratorium would be enacted by the Council, but the trick is that it needs to identify a gap or a shortcoming or some issue with existing town ordinances, that unless fixed, in the opinion of the Council would lead to substantial negative impact or an emergency of public resources. The issue with a moratorium in this area that LD 1829, even if it may be amended, is essentially restricting home rule authority and instructing municipalities on what you can and can not do.*

*He said the general concern is that LD1829 and LD2003 before it is not meant to give municipalities an option; it is meant to instruct municipalities on what changes need to be made to their own land use ordinances in order to comply with that statute. They can explore this and it is true until that legislation is changed, Windham and all other towns where the Council is the legislative body until of July 1 of next year, need to come into compliance. It is not clear what technically happens if the town does not do that, but it would create a lot of problems and challenges for town staff on how to implement existing town ordinances and regulations if they were not consistent with LD1829 and create some legal challenges for the town as well. Councilors asked the attorney several more questions.*

## **XII. Town Manager's Report.**

*Manager Burns reported on the following:*

*Bob thanked Linda for all of the years of service and said there is a celebration for Linda. The Town Clerk's retirement party will be on Monday, November 24th at 2:00 p.m. in the Town Hall Gym.*

*He thanked the outgoing Town Councilors. He gave them each a wooden plaque with the town seal and a gavel attached thanking them for their years of service on the Council. He asked them to please stay involved.*

*Windham had an official case of rabies in a raccoon last week. If you see animals acting oddly, please keep yourselves and your pets away from them and give Animal Control a call at 892-1919.*

*Our Medical Loan Closet is going to move to the East Windham Fire Station. That will be on November 10 and it will provide people a better location with heat, running water and security.*

*The Planning Department was able to achieve Delegated Storm Water Review Status with the DEP. They have a few more hurdles to get over.*

*Chief Schofield would like to mention that he is looking at a temporary no parking area in the Brookhaven subdivision for Halloween.*

*They have open positions for in the Police and Public Work's Departments. They are looking for CDL drivers.*

*They are evaluating phone system bids. They have received 16 bids, the current one is becoming obsolete.*

*Last week Linda had issued almost 1,700 ballots and about 600 had been returned. On Thursday, October 30th, the Clerk's Office will be open extended hours from 4:00 to 7:00 p.m.*

*There is a Rabies Clinic scheduled Saturday, December 6 from 8:30 to 10:00 a.m. in the Town Hall gym, and shots are \$15.00 each.*

*The waterline construction on Chute Road is still going on.*

*The River Road waterline extension for the associated development project is ongoing. Some folks were troubled and they apologize but it is better for the community.*

*He rode with the Fire Department, along with Councilor Reiner and Councilor Jones and took their ATV and explored the East Windham Conservation area and checked out the new constructed trail. It was a Monday and the parking lot was a third filled. There were mountain bikers, hikers, people with pets and well used.*

*Manager Burns said there was a meeting and they voted on the rates for FY2027. A 3% increase in solid waste tipping fee but a really large increase, \$85 up to \$110.75 for recycling. The recycling market has crashed and they are having a hard time marketing the recyclables. The market expects clean recyclables and with the current facilities they have had a hard time delivering those. There is a large capital project to expand and modernize the facility. There is new sorting equipment to bring our recyclables to the forefront in terms of resale value. He said part of the increase is to pay for that facility. A law was recently passed where Maine was the first in the nation to pass this extended producer responsibility EPR law that basically creates a revenue stream from packaging. It will be similar to a bottle bill, and it will add a surcharge onto the packaging of various products. The money will accumulate at the State and they will reimburse it to the communities.*
