Good day,

The SPGrant committee met today to review the requests for National Opioid Funds and the following is the notes from that meeting.

In attendance was Phil Rossetti, Mark Morrison, Mike Duffy, Marge Govoni and Bob Burns, Asst Town Manager.

The committee reviewed the purpose of the fund and its possible disbursement. We also agreed to have another meeting at a later date, with Town Manager Barry Tibbetts, to have further discussions on the requirements for the awarding of these funds.

We reviewed the application for MEDI BOX HARM REDUCTION and we agreed unanimously that it met the intent of the distribution of said funds. We are recommending that this program receive the full amount of \$4,800 as requested.

We reviewed the application for FAMILY FUN FESTIVAL and voted unanimously to NOT fund this program due to its inability to meet any of the distribution criteria exhibits.

The National Opioid Fund balance of \$22,158.35 will be reduced by \$4,800 leaving a balance of \$17,359.35 if our recommendations are accepted.

Next meeting and whether it's Zoom or in person is TBD.
