

HOPKINS DAM REPORT



The replacement of the oak seals on the dam was completed in March 2014 and fittingly the heavy snow load we experienced last winter immediately tested the integrity of the structure under a maximum load. The repair work done by D&J Vance was under estimate, on time, and very well done. Other than the normal maintenance I do not anticipate any major work on the dam mechanical structure in the foreseeable future.

We have had a normal summer with a wet spring and somewhat dry August and September. The water level high point was July 4th when after a heavy rain the lake reached +4" above summer level.

The dam was opened on September 24th, 21 days ahead of the scheduled October 15th opening date after the LSLA board agreed to a request by the state to accommodate the ramp construction by lowering the water level.

The Hopkins Dam on Little Sebago Lake is in good operating condition, the granite block structure is sound with no visible movement or cracking.

The "Submerged Land Lease" with the State of Maine was completed and filed in the spring and work on the 2 year EAP renewal will be completed and filed by the June 2015 deadline.

We are as compliant as the owners of a 120 year old dam can be....

The Milfoil Militia was out in full force this The fleet was upgraded this year to prevent "hassles" from the past which made the operation inefficient. Our scouts were out in early July when the plant has lifted from the bottom due to the warmth and sunshine to visits the past areas and look to see if new spots developed. This allows for the team to identify a plan of attack and prioritize areas to We hired an intern from UNE who is majoring in invasive plants to assist us with a new approach to survey and map the areas utilizing a program the Natural Resources of Maine was introducing. This will keep a record from year to year of the areas extracted, amounts taken and date.

The extraction began in the upper basin while the lower basin was surveyed. After a week the upper basin was groomed and the efforts shifted to Beaver Cove, Mumford Cove and then to the lower basin. We revisited to regroom every three to four weeks. Throughout the year we received various reports from residents saying they think they have milfoil in their area. Our scout was sent out to identify if it was a native or invasive plant. Most of the

time it was a native plant which we encourage to maintain to avoid the invasive to take hold in your area.

We encourage this reporting to make sure we address little pockets that may appear and encourage all residents to become familiar with the difference between variable milfoil (invasive) and water marigold (native) since they are initially so similar when looking from above the water. Please visit the VLMP website www.mainevlmp.org to learn about variable milfoil, how to identify it and become part of the plant patrol team.

The middle lake, due to its depth, does not seem to have as much milfoil although a few shoreline areas including islands have had reports of milfoil which we found and extracted; Bean Island and Policeman Cove are some of the areas that will be monitored going forward. The lower basin continues to be challenging but this year there was a decline in plants extracted. The beds do not have the density of plant as before, which is good, but the smaller ones are harder to find and takes as much time to hand pull and feed into the suction

dredge called HIPPO (Hydraulic Invasive Plant Processing Operation).

Next year after the initial grooming, a new approach will be developed to survey the first couple of days and then extract utilizing a diver and an assistant in the areas that have scattered plants. The good news is that this year we had to stop the operation the end of August due to the fact we were not getting enough plants to justify the use of the HIPPO's. The invasive plants are there, they are scattered and if left alone will become the dense bed we once had. This is why we need to continue, continue with a different plan of attack and continue to be vigilant.

The breakdown the amount of milfoil extracted is below. One has only to think about what would happen to our lake and property values if this operation had not begun almost 15 years ago. Lastly, I need to thank all the volunteers who made this operation happen. Countless hours strategizing; use land for boat docking; allowing the crew to

invade their spot early mornings and afternoons; summarizing, maintaining, winterizing the fleet, and surveying reported sighting are just a few of the things that volunteers have given to protect our lake.

Two of these special people are leaving us after 10 years of dedication, Leo Shanahan and his wife Theresa. Leo supervised the daily operations and Theresa scheduled the crew and assisted with payroll reporting. We will miss their daily presence but know that their hearts will still be there; Leo I will make sure you have plenty of milfoil marker throw while you are in those special fishing spots!!!

I remember when...

Did you know...

Here's a little history about Lyons Point, provided by Deb Gellerson, a long-time resident.

In the 1940's, a man by the name of William Kincaid was an accomplished flutist with the New York Symphony, and later first flute with the Philadelphia Symphony Orchestra. Around the same time, he purchased a camp on the Point and owned both shorefronts. He built several small cabins on his property to house music students and ran a summer music camp there for many years. On many summer evenings, people would park their boats in the cove on the south side of the Point to listen to the music sessions that were held on the deck that is now part of Deb's home.

One of his cottages still exists as bunkhouse. The electric line that provides electricity to the Point is named the Kincaid Line, and there is a Kincaid Lane on the Point with an island at the end also named after Mr. Kincaid.

William Kincaid was introduced to Little Sebago when he stayed at Aimhi and fell in love with the area. Many of his music students worked and lived there as well, and he often went over to Aimhi for a good meal.

BASIC BOATING DO'S & DON'TS

Did you know...

- The driver of a boat over 10HP must be over the age of 12.
- All boats towing water skiers, tubers, etc must stay 200 ft. From shoreline unless dropping off or picking up.
- If you are towing a water skier, wake board or tube that you must have an observer in the boat. The driver should never distract themselves from their first obligation-driving the boat safely. Also, be sure the person being towed has on a life vest.
- Children under the age of 10 must wear a life jacket in a boat at all times and that there needs to be an adequate number of life jackets in the boat for all riders.
- Paddle boarders must also wear a life preserver, or at least have it on the board.
- You must be at least 16 to operate a jet ski, and all operators need to wear a life jacket, and jet skis are not allowed on the lake after sundown.
- It is illegal to make repeated circles, jump wakes, race or harass another watercraft.
- Harassing wildlife with a jet ski or any watercraft is illegal.
- The slalom courses on the lower and middle lake are private and should be used to slalom through, not run in and out.
- That drinking in a boat on a public water such as Little Sebago is a violation of the law.
- Fire extinguishers are required in boats that have inboard motors and enclosed compartments, not including bait wells, glove compartments and slatted floor areas. Check laws for specifics.
 NEVER USE WATER TO PUT OUT A GASOLINE FIRE.
- Littering our lake with any debris is illegal and subject to fines.
- When traveling through the upper and lower narrows, the boat that gets there first has the right of way.
- Little Sebago has many areas that are shallow with rocks, some marked and some not. At the
 end of the season, water levels diminish. Being cautious could save time and money avoiding
 damage to your propellers.
- The red, yellow and green noodles in some parts of the lake mark areas of milfoil. Please avoid these areas to keep from spreading the plant.
- It is illegal to carry hitchhiking plants on your boat into our lake and if discovered you will be subject to a fine.
- Milfoil stickers are required on all motorized, registered watercraft. Fines currently are \$500 for violators.
- All islands are private property. It is trespassing to pull up to and use the islands on our lake for any purpose.
- The months from May to July are when our loons are nesting and eggs or chicks are very vulnerable to intruders.

WE NEED YOU! - HOW CAN YOU HELP?

Our lake enjoyed a healthy number of loon chicks this summer. We had five confirmed on the middle lake, two confirmed on the lower lake, and possibly one in the upper lake by the narrows. Considering the threats that loomed from the eagles above to the bass and turtles below, Little Sebago Lake enjoyed a great summer watching our chicks grow under the watchful eyes of their parents. If you have been following the Little Sebago Lake Facebook group, some great pictures and stories have been shared of our loony residents this year.

This winter, your lake association will be working on plans to enhance and promote protection for the Loon population. We need to get the word out to more of our new neighbors and guests who visit our lake on proper behavior around Loons while nesting and caring for their young. We have witnessed too many incidents this summer of harassment and total disregard of their needed privacy. We hope that you all will be vigilant in spreading the word to help protect these wonderful birds we love hearing in the still of the night!

Since 1983, volunteers across the state have visited their local lakes and ponds the third Saturday in July with a pair of binoculars and a shared passion – protecting the Maine loon and its habitat. The project conducts an annual loon count to assess the status of the loons in Maine. Please visit www.maineaudubon.org/loons for more information and learn how you can become involved.

For 2014, we had a strong count of both adults and chicks this year. Though all good news, we also heard disturbing news of boaters of all ages harassing the loons and their young. We all must educate our children, friends, and visitors about how fragile the ecosystem is, including our loons. Approaching nesting loons scares them off their eggs leaving them vulnerable to predators and cold temperatures. Approaching loons while protecting their young will stress them out causing them to take off leaving their young open to other dangers such as eagles. How we behave around them will affect how our future counts are affected. Stay away and observe using binoculars.

PUBLIC BOAT LAUNCH UPDATE By Pam Wilkinson

We are delighted to PUBLIC BOPA meet and greet all who enter and leave our lake. Our Courtesy Boat Inspectors look for fragments of potentially invasive plants on all watercraft going into and out of our lake. To date, no suspicious fragments have been found on the 2089 boats inspected this summer. Interesting that in 2010 the 971 boat count was up 230 boats compared to 741 in 2009 for the same time period. It is obvious that the usage on the lake has increased at least 100%.

In addition to their inspection responsibilities:



- > Jackie and Jimmy keep the area mowed and clean.
- They have free informational brochures available regarding milfoil, hazard markers, etc.
- Offer LSLA merchandise (including maps) available for sale.
- > They also remind people if their stickers have expired
- Inform people on what safety equipment is required.
- > Try to spread the word that islands on the lake are private and not toilets.

The IFW is revamping the launch to allow for proper launching and creating a plunge pool at the end to for power up onto trailers. In the spring a loading dock will be added.

We hope all who use this facility appreciate the time and effort it takes to keep things moving smoothly, and give a special thanks to our dedicated inspectors who do much more than inspect boats. You will recognize them this year wearing the CBI special T-shirts!

Safety Patrol Program

The summer of 2014 was a very active one on the lake. The Safety Patrol Boat was out most every weekend with volunteer drivers and deputies from the Cumberland County Sheriff's Department. There were quite a lot of violations noted this year. Most of them involved driving too close to shore, not enough life preservers on board, and unregistered boats. Please take a few minutes to read the Boating Rules and Regulations handbook that is available from the State of Maine, and from both Windham and Gray town halls. We also have them on board the Patrol Boat and always try to give one out if you are stopped.

Over the course of the summer we checked hundreds of boaters and passed out life jackets, maps, brochures and any other item that was needed for their safety. And as a reward for safe boating and following all of the rules of the State of Maine, we eagerly handed out coupons for free pizza from Pizza Hut, and free sandwiches from Subway.

I want to thank Dale and Diane Burnell, Pricilla Cutts, Eric Ziskend, Marc Lamontagne, and Jeff Wilkinson for volunteering to drive for the program this summer.

My intentions are to have the boat out even more next summer and could use a couple more volunteer drivers. Boating experience and knowing our lake are the basic requirements. I will have a training session in the late spring. If you are interested, please contact me, Sharon at 892-3157.

Little Sebago Lake Protection Project IV

Phase IV of the Little Sebago Lake Protection Project is underway to protect Little Sebago Lake's water quality. Through this project, opportunities are available for landowners and road associations to improve their land and protect the lake's water quality through professional recommendations, material and contractor discounts, and possible cost-share grant funds. Over the next yearand-a-half, twelve high priority road sites will be sought out for road improvements and provided with cost-sharing grant funds and engineering oversight. In addition, there is currently an initiative to explore the formation of a Little Sebago Lake private road association cooperative in which road associations are pooled together to obtain bulk discounts in materials and services. All participating roads will also have the opportunity to work with CCSWCD to obtain a 5-year road improvement and maintenance plan. The first meeting to discuss the feasibility of a private road cooperative was held in Gray on July 22nd. The next meeting will occur near the end of October.

For residential sites, free technical assistance is currently being offered providing recommendations on what individuals can do on their property to protect the Lake's water quality. Through CCSWCD's Clean Water Works program, residents are provided with an on-site visit and recommendation report. Over the winter, all residential needs will be compiled and bulk material and labor discount rates will be pursued to be offered in 2015. To date, 15 site visits have been conducted on Little Sebago Lake.
