<p>FUNDING AWARD & DISBURSEMENT</p>	<p>The Town's Substance Prevention Grant Committee will review applications and select funding recipients. Applicants will be notified of the Committee's decision in a timely manner. The Committee reserves the right to grant all, or any part, of the total amount requested.</p>
<p>APPLICANT DELIVERABLES</p>	<p>Fund recipients will be required to submit a Progress and Final Report to ensure completion of all project activities. The progress report shall update the project timeline and ensure project completion. The progress report will be submitted to the Town's Substance Prevention Grant Committee, or designee, mid-way through the project timeline after receiving funds. The Final Report will be submitted in a timely manner after project completion.</p>

A. A STATEMENT OF THE EDUCATIONAL VALUE OF PROGRAM	This will be a hands-on building club where students will build their very own working electric guitar that they will get to keep. Students will learn about high-quality work and how important it is to sand and finish their guitar body to have a flawless smooth finish.
B. THE PROGRAM GOALS & OBJECTIVES	Open to anyone (even if you can't play the guitar) to come in work with your hand and build a working guitar. Students will learn about tools and lab safety. Learn the proper way to sand a piece of wood. Taking pride in your work and spending the time needed to perfect the guitar body. They will have the opportunity to cut their head stock, and polish the frets. In the end you want to have a guitar that someone would think you paid hundreds of dollars for, but you build with your own hands.
C. THE PROGRAM CREATOR & TARGET AUDIENCE	I (Jason Lanoie) will be the advisor for the club. Currently being offered to the 7th graders as an afternoon club, I have 10 members this year. The intent is to hopefully have some of those students (next year as 8th graders) join us again to help as advisors for the new group that joins next year.
D. HOW THE PROGRAM IS MONITORED FOR SUCCESS. WHO IS RESPONSIBLE?	As the teacher/advisor I work with the members of the club to make sure they are spending time needed to make sure they sand and finish for a quality guitar. Updates are also posted on this site: Guitar Club
E. ADDITIONAL FUNDING RESOURCES FOR YOUR PROGRAM	The Perloff foundation has funded some of the tools and supplies. I believe there will be future funding as well for some supplies, they will not provide the guitar kits.
