Tony Plante: Tony reminded people that we will be closed on Christmas Day and New Years Day, and that we are closing at 1:00 p.m. on Christmas Eve and at 3:00 p.m. on New Year's Eve.

He reminded people that if your trash and recycling pick-up day is on those two Thursday holidays your trash will not be picked up on those days, but it will be picked up on Friday both of those weeks.

There is a Special meeting on January 20, 2015 to work on capital planning i.e. facilities buildings, roads, etc., and they will be talking more about it at up coming meetings during agendas and scheduling, also with regard to the Manager's evaluation process, which is a discussion item tonight.

For the meeting on January 13th they are planning Council consideration of the next round of harvesting at the Lowell Preserve. Before that they are sending out a letter to some of the people who have provided comment following the last harvest in 2013, and they will be holding a meeting with them and any other interested parties at the East Windham Fire Station, Saturday, January 10, 2015 at 1:00 p.m. in the Community Room and conditions permitting, they will do a site visit to see some of the areas that were harvested in 2013 and other areas planned for the next round of harvesting. The meeting will be with Mike Mains our Forester.

Councilor Chapman: Reported that they had not met, but said they still need to pick a Chairman for that group, and she would like to have a brief meeting before the Special meeting on the 20th.

Chairman Nadeau: He said they had not met as Ben Smith has been busy with the Comp Plan.

Councilor Gleason: Reported that they have had one meeting, and he's talked to Doug and letters have been sent to the two roads they have had problems with. They know there are lawyers involved between people on one of the roads, and they will not have service next year unless the improvements are done by July 15th.

Councilor Gleason: He reported that the last meeting was on the 17th, and they talked about the TiF and what they were planning to do with it. They talked about high speed computer services and to continue working on simplifying the Planning process.

They split the work up among the five different bullets that were part of the revised charge, and they will be working as individuals or in small groups on those and coming back to the group as a whole in mid January.

Councilor Gleason: He saw the building today and he was impressed, but he wants to see how much it will cost to renovate it before a decision is made.

Councilor Muir: He asked if contingency is the only place we can get the money from? Tony, said the short answer is yes, there is no other area in the budget where they have allocated this much for consulting fees. There are other parts of the budget where we have consulting fees, but a lot of that has been taken up with expenses of the Police and Fire Chief's search.

Councilor Chapman: She went down today as well, and thanked Peter Anania for

allowing them to look at it. She said there are sprinkler systems in there, and if another door has to be put in, will they give us an idea of how much it will cost? Tony said the \$6,800 will also help cover that. It is looking at the existing building, its structure and systems against the program for the South Windham Fire Station.
