Windham Municipal Code of Ethics **Statutory Standards**: "There are certain provisions of the general statutes of the State of Maine which should, while not set forth herein, be considered integral part of this Ordinance. Accordingly, the provisions of the following sections of the general statutes of the State of Maine, as may be amended, are hereby incorporated by reference and made part

of this Code of Ethics, and shall apply to all Town Officials of the Town of Windham whenever applicable as (if) more fully set forth therein, to wit:

17-A MRSA SS 603 Improper Influence 17-A MRSA 608 Official Oppression 17-A MRSA 609 Misuse of Information"

Reference Page 6: "Political Standards of Conduct

A. No Town official shall participate in any political activity which would be in conflict or incompatible with the performance

of his or her official functions and duties for the Town. In conjunction therewith:

B. No Town official may use his/her official authority or position for the purposes of influencing or interfering with or affecting the results of any election..."
