## AMENDMENT TO CONSERVATION EASEMENT EAST WINDHAM CONSERVATION AREA

This AMENDMENT TO CONSERVATION EASEMENT is made this 21st day of September, 2023 by and between the TOWN OF WINDHAM, a duly organized Maine municipal corporation, located and operating in Cumberland County, Maine and having an office at 8 School Road, Windham ME 04062 (hereinafter "GRANTOR," or "LANDOWNER" which words are intended to include, unless the context clearly indicates otherwise, the above-named GRANTOR, its successor and assigns, and any successors in interest to the Protected Property), and the PRESUMPSCOT REGIONAL LAND TRUST, a Maine non-profit corporation with a mailing address of P.O. Box 33, Gorham, Maine 04038 (hereinafter "HOLDER," which word shall, unless the context clearly indicates otherwise, include HOLDER's successors and/or assigns).

WHEREAS Grantor granted to Holder a conservation easement dated September 21, 2023 to be recorded in the Cumberland County Registry of Deeds in Book Page (the Conservation Easement) on 697.4 acres of land (the "Protected Property") located in the Town of Windham, as more fully described in the exhibits to the Conservation Easement; and

WHEREAS Grantor has subsequently acquired via a release deed additional acreage contiguous with the Protected Property which it desires to encumber with the Conservation Easement, which additional lands are depicted on a plan entitled "Boundary Survey, BICS, LLC Parcel B, off Falmouth Road - Nash Road, Windham Maine" dated February 2023, prepared by Survey, Inc. and recorded in Cumberland County Registry of Deeds in Plan Book 223, Pages 284 as "Area In Question" (hereinafter "Contiguous Acres");

WHEREAS the Grantor and Holder agree that amending the Conservation Easement to add the Contiguous Acres enhances the conservation values intended to be protected by the Conservation Easement;

NOW THEREFORE, in consideration of the foregoing recitals, Grantor and Holder agree as follows:

- 1. The above set forth recitals are incorporated by reference and made a part hereof.
- 2. The Conservation Easement is hereby amended in its initial paragraph to expand the definition of the Protected Property so that the clause beginning on the fourteenth line of Page 1 reads:

"...more particularly described in **Exhibits A-1 and A-2 and A-3** and approximately as depicted on the map of the property at **Exhibit B** attached hereto and made part hereof (hereinafter referred to collectively as the "Protected Property")."

- 3. The Conservation Easement is hereby amended by adding immediately preceding Exhibit B the exhibit attached hereto which is labeled "Exhibit A-3".
- 4. The Conservation Easement, as amended hereby, is hereby ratified and confirmed, and shall remain in full force and effect.


