**KENNEL, MAJOR** — An establishment in which five or more dogs, cats, or domesticated animals are boarded for a fee or compensation. (See Article 5, Performance Standards.)

**KENNEL, MINOR** — An establishment in which four or fewer dogs, cats, or domesticated animals are boarded for a fee or compensation. (See Article 5, Performance Standards.)

Included in this definition and without limitations This definition includes, without limitation, are pet care service establishments for dogs and cats, that provide daytime care or boarding (short-term care during normal business hours without overnight boarding, i.e., doggy daycares) and/or overnight care only. Veterinary clinics are excluded from this definition when boarding is incidental to medical treatment; provided that such boarding is not offered as a separate service unconnected with the provision of medical treatment. (See Article 5, Performance Standards.)

b) ~~Overnight boarding: Shall completing the structure with appropriate sound damping measures.~~

c) ~~Odor Management: Animal waste shall be managed to prevent odors detectable beyond the interior space and/or property lines, the legal boundaries of the lot.~~

3. ~~Hours of Operation: Major kennels may be open to the public from 6:30 AM to 6:00 PM. Overnight boarding may occur as necessary, but shall observe "quiet hours" from 6:00 PM until 6:30 AM at which time all boarding animals shall be kept inside. Daytime care [6:30 AM to 6:00 PM]; Overnight boarding quiet hours [6:00 PM to 6:30 AM].~~

4. ~~Capacity: All facilities providing overnight boarding for dogs shall ensure that each animal is provided with adequate space to promote health, safety, and comfort. For cats, four (4) square feet. For small to medium-sized dogs (5 pounds to 60 pounds), the minimum required floor area shall be sixty-four (24) square feet per dog. For large dogs (60 pounds to 150 pounds), the minimum required floor area shall be one hundred ten (40) square feet per dog. A minimum of 192 square feet for a family of five (5) or less dogs. These standards apply to all overnight and daytime care accommodation and must be maintained at all times.~~

a) ~~Daytime care operations shall be limited to a minimum of 72 square feet of area per dog. These minimum requirements are intended to ensure proper supervision, reduce stress among animals, and maintain sanitary conditions. Operators are responsible for implementing procedures that prevent exceeding this limit.~~

b) ~~All facilities subject to these requirements shall maintain accurate records demonstrating compliance with space and capacity standards. Such records must be made available for inspection upon request by the appropriate regulatory authority.~~

c) ~~Occupancy permit; shall meet the Maine Department of Agriculture, Conservation, and Forestry Chapter 701: Rule Governing Animal Welfare~~

5. ~~Licensing: Must maintain and display current State of Maine license for each kennel and boarding kennel, pet shop, and shelter. All major kennels shall be licensed to the extent required by 7 M.R.S. § 3932-B, as may be amended or recodified and shall operate in compliance with other applicable state statutes and administrative regulations, including but not limited to 7 M.R.S. § 3932-B and 01-001 C.M.R. ch. 701, which shall be incorporated by reference as conditions of approval on any granted permit.~~

  4. Capacity: All facilities providing overnight boarding for dogs shall ensure that each animal is provided with adequate space to promote health, safety, and comfort. For cats, four (4) square feet. For small to medium-sized dogs (5 pounds to 60 pounds), the minimum required floor area shall be sixty-four (24) square feet per dog. For large dogs (60 pounds to 150 pounds), the minimum required floor area shall be one hundred ten (40) square feet per dog. A minimum of 192 square feet for a family of five (5) or less dogs. These standards apply to all overnight and daytime care accommodation and must be maintained at all times.
    - a) Daytime care operations shall be limited to a minimum of 72 square feet of area per dog. These minimum requirements are intended to ensure proper supervision, reduce stress among animals, and maintain sanitary conditions. Operators are responsible for implementing procedures that prevent exceeding this limit.
    - b) All facilities subject to these requirements shall maintain accurate records demonstrating compliance with space and capacity standards. Such records must be made available for inspection upon request by the appropriate regulatory authority.
