Manager Tibbetts said that this had previously been discussed at a couple of other council meetings. This is a result from applications that came in to this program, and they realized that there are some residents who had not lived here a full ten years but have lived here longer than five years that would not qualify because of that time limit. From a financial perspective they certainly would qualify and it would be of great help to them.

Patrice Leary-Forrey the Project Director for Be the Influence said this is a project by the youth from the Windham High School that was presented to Council and has gone through the process. They support the change in the signage from No Smoke, No Tobacco to include Vapes, Marijuana and any other substances that are combustible.

Madeline Cyr is a Community Health Promotion Worker with Portland Public Health. They serve all of the County and she wanted to highlight the importance of having language on signage and why she supports this so much. It is because when they say "No Smoking" that can mean a lot of things. Having Vaping and Cannabis included in that is going to be incredibly helpful in keeping our parks smoke free.

Assistant Manager Burns said smoking is being further defined in this change but also there are two other items. Firearms and Fireworks they are adding at East Windham Conservation area in this ordinance and there were some minor spelling and punctuation mistakes.

It would read:

A tie vote shall result in postponement of the motion to the next meeting, not a failure of the motion. Only one (1) postponement for a motion is allowed. If the vote remains tied at the second vote, the motion fails."

Barry said it has been an effective way for the Planning Board to handle tie votes, and thought it would make sense for the Council to consider this as well.

WHEREAS, Windham, like many towns, has seen an influx of new residents who want to live here; and

WHEREAS, Windham has recently been named one of the top ten "hottest zip codes in the country"; and

WHEREAS, the prices of houses in Windham have increased substantially since the Covid 19 pandemic; and

WHEREAS, young families are finding it difficult to find affordable housing options; and

WHEREAS, there are residents in our community who have lived here for many years; and

WHEREAS, these long-term residents include senior citizens who live on fixed incomes; and

WHEREAS, Maine's Constitution and statutes require reassessment of properties which has resulted in some long-term owners incurring substantial and unexpected increases in property taxes, with newer homeowners also experiencing significant hikes due to shifts in the property tax burden; and

WHEREAS, the State Legislature has the sole power to enact changes in the property tax system, to enact other measures to reduce reliance on property taxes as a revenue source and, if appropriate, to submit Constitutional amendments to the voters;

NOW THEREFORE BE IT PROCLAIMED, that the Town Council of the Town of Windham calls upon the legislative delegation, Senator Timothy Nangle, and Representatives Barbara Bagshaw and Mark Cooper to work toward a more fair and equitable system of real property taxation, as well as other measures to reduce property tax burden which may include but is not limited to the following:

1. Substantially increase the Homestead Exemption, and fully fund the lost revenue reimbursement to municipalities;
2. Authorize a real property transfer tax that is paid at the time real property is sold;
3. Authorize local option taxes that allow towns to impose local sales taxes;
4. Increase the property tax fairness credit and consider additional, means-based property tax relief programs;
5. Increase the state revenue sharing and/or revamp the formula so that communities with high values and lower tax rates are not penalized;
6. Authorize a local sales option for a marijuana use tax for those municipalities selling it; and

7. Conduct a Fiscal Impact Assessment on any legislation that affects municipalities prior to legislative voting.

Dear Town Councilors and by extension, residents of Windham.

I thank you for the invitation, but must decline at this time due to a scheduling conflict. I would appreciate it if you would read this statement at your meeting:

As a State Representative from Windham, I have consistently opposed legislation that increases property taxes. Unfortunately, over my opposition, the last legislature took several steps that will increase property taxes statewide.

- It eliminated the Senior Property Tax Stabilization Program after only one year rather than addressing its flaws in order to help seniors remain in their homes.
- It eliminated future negotiated increases in the Homestead Property Tax Credit.
- It removed a bipartisan property tax levy limit that protected homeowners from increases over and above income growth without voter approval.

To assist Windham taxpayers, I will support reinstatement of those items and look for additional ways to lower property taxes this session.

In general, I do not favor allowing municipalities to add additional layers of taxes on people that are already struggling to remain in their homes and keep up with the ever increasing cost of living in Maine. I am willing to consider anything that will directly lower property taxes in Windham. Please feel free to contact me on pending legislation of interest to you this coming session. I appreciate your public service and value your advice. We truly live in a wonderful community.

Manager Tibbetts said they passed the Sewer Ordinance last week for the North Windham area, the fees were in there. All they are doing is moving the fee structure that is in there into the Master Fee Schedule. Two years ago they moved all the fees out of all the ordinances and into the Master Fee Schedule. That way it is easier to see it and to make any amendments.

Councilor Maxfield asked about the buy-in fee? Barry said the buy-in fee is when you go to connect to the sewer prior to January 1, 2026 the fee is \$3,500 per unit. After January 1, 2026 the buy-in fee is \$5,000. This is an incentive to make sure any new businesses coming in would pay for the additional capacity that we need to build out in the sewer treatment plant facility. The stand-by fee is to be determined.

Assistant Manager Burns said from the meeting that occurred, they did vote to increase both the solid waste rate and the recycling rate. The solid waste rate is \$107.50 per ton and the recycling rate \$85.00 per ton. He said he promised to get back to the Council about what is happening with our tonnages now that we have transitioned to the automatic side load collection system, and tonnages are up. He compared last year's two month period, September and October to this years and we are up just over 250 tons. It was a significant increase and was anticipated. He said they will be watching it closely over the coming months, but expect it to level out to where we have been in the past.

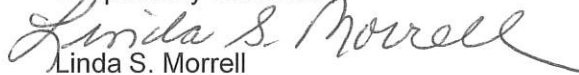
