A public school guidance counselor in Maine caused a stir by bragging to a father that she would secretly handout breast binders to female students.

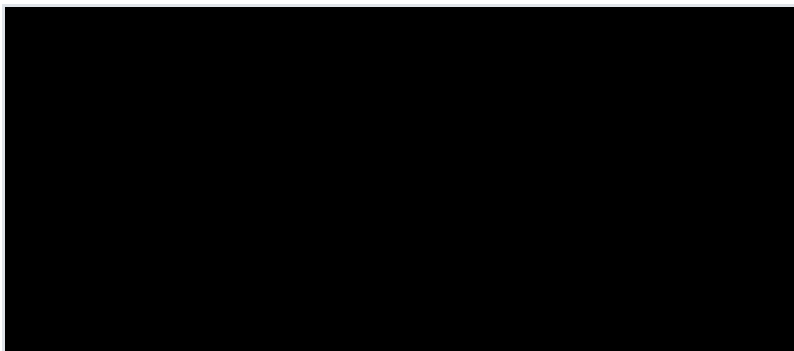
I was there for the above incident and long story short, during a School Board meeting in early 2023 Turpen stood up and interjected herself into a private conversation being had by a parent and another community member. Turpen said repeatedly, three times, in front of some of the school board members and the Superintendent, Chris Howell, (who over saw and over heard), as well as several parents (myself included) and community members that she would in fact put a chest binder on that parents minor child without them knowing. Turpen was visibly and vocally proud of the fact she would do it without the parents knowing and with out any parental communication. This demonstrates abuse of power and lack of communication. To me, as a parent, this is quite frightening that she would do anything physical to a minor child without parental communication and/or consent for a minor. Turpen was employed by another school district at the time, unsure of her role, but I do know briefly after this incident, she was no longer employed there but unsure why. Were Turpen's references checked prior to recommendations for the committee or being appointed a member?

I do not believe Howell took any action about the incident, even when the concern was brought to him. Howell may be able to speak otherwise, I am not sure. Also, after this incident Turpen was permitted to be around students as she participated in a graduation ceremony with Howell present. This made Turpen appear as a role model and that the school endorses her behavior.

Had Howell informed the Counsel of Turpen's actions, would you have reconsidered appointing her? As you will note by this article below, this is not the first time Howell has withheld information regarding sexually related behavior; first of a student and now a member of our community.

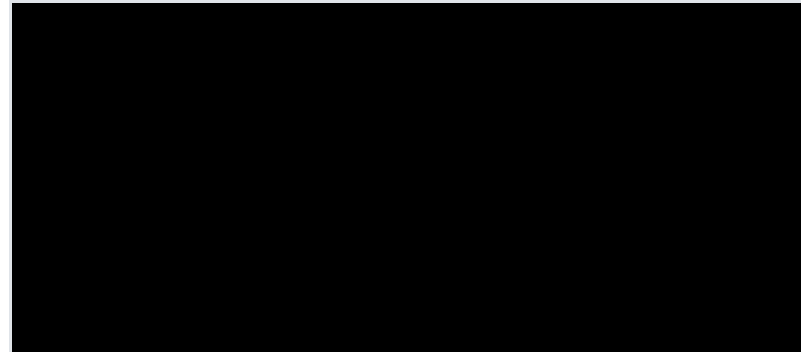
