Kevin Finkenaur the owner of Liberty Bell Moving Company asked if there are any plans to automate the process when a business is found to have violations to make it easier for the businesses to work through the violations with Code Enforcement? He said they currently email him a PDF with a million non-descript pictures, half of which are not violations, and they expect somebody, who isn't really familiar with all of the codes to decipher that based on what they know or what they don't know.

He asked if there was a plan to automate the process to make it easier for businesses, and instead of the PDF send them a link and options to choose from?

He said he could not get any answers because you are relying on emails and PDF's, it's a mess. He suggested implementing a software program that wouldn't cost more than \$80,000, and it would make his life a lot easier and him getting fined \$5,000 because people can't send emails back or explain things to him properly.

Manager Tibbetts said under our current practices the town does their inspections, there is a listing of the violations that are made, and we try to track those and back them up with photos and information and detail them out in the format of an email or a letter, but emails are easier and effective. He said when there are a lot of violations it is a lot of information. He said he is not sure there is a program out there that does it but he will take a look.

Manager Tibbetts said the Public Works Department was able to create a pathway between the current Community Park and the parking lot at the Fire Station.

Christmas lights are going up and he thinks they are all in place now.

The Scanning project, which they have been working on for several months has ten of the twenty-six cabinets done. He said that is a lot of paperwork to be scanned in, and hopefully in a month or two they will be able to bring in a demo to show the Council. Once this is done you will be able to click on a parcel and you will see all the history of that parcel, any permit or anything that has happened to that parcel will be available to you.

At noon onDecember 2 the East Windham Conservation will have a dedication. There will be some optional hikes to go on, five miles or less to choose from. It will be held behind the East Windham Fire Station/Lowell Preserve. From there they will walk into the new East Windham Conservation area. The reason it is being held there and not at the entrance on Falmouth Road is they are still constructing the parking lot, and there will be blasting during the month of December, and then construction of that parking lot will happen in January and February.

On December 12 the Rec Department and Library are hosting a Senior Tea Party.
