Please note that the Maine Freedom of Access Act provides access to documents but does not require municipalities to compile information from several documents to fulfill a request. Please find the attached original advertisement from our last tax-acquired property sale in 2022 and the bid results for each parcel. Please note that the awards for the two Emily Lane and two Hunts Drive vacant parcels were awarded to the second-highest bidder as the highest bidder backed out. The Town Council acted on these awards at their meeting of November 10, 2022. Proceeds from the sale of the condo unit that exceeded taxes/fees due was returned to the previous owner.

Prior to the 2022 process, the Town sold one commercial property, 112 Roosevelt Trail, in 2019.
