Since this is a public document and some outlandish and false claims have been made here I will put the facts in the record :

- 1. I just spoke with the Town Clerk who most emphatically stated she DID NOT tell you that this group or the signs were in violation. That is another lie.
- 2. In my first reply I posted a picture of a sign that was at the end of your RD that was placed by a group who calls/called themselves Parents Choice Windham which opposed the school board budget and that sign was not marked with a personal name but a group name. Your initial emails say a personal name and address are required yet they are not and that sign is an example. Also of note was that sign did not have an address of any kind, let alone a PO Box. Were you associated with that group or a member of their Facebook private group? Did you place that sign at the end of your Rd? You can consider those rhetorical questions because I really don't need the answers but am showing an example of how you are incorrect in your accusations and possibly worked with a group who actually made the mistakes you are accusing others of.
- 3. You again have made incorrect and defamatory accusations and using words like laundering when you have zero basis or facts and those out right lies. The facts are there are two groups formed that have two separate EIN numbers as our required to open the individual bank accounts that each separate group has for donations and expenses. One group is a Political Action Committee and the other is a Ballot Question committee all setup properly and operating under Maine State guidelines. There is no laundering or crossing of finances, each group is separate.
- 4. These groups have not hit the donation or single expenditure thresholds required by Maine Election Law to be required to file reports with the clerk and are not associated with the candidates so any questions about a specific candidate filings would need to be directed towards the candidate.

5. Again more defamatory lies. I never setup a Facebook page or used my own funds for a Vote Yes for the town garage. Please show any evidence of these lies. And when did I argue online DURING a council meeting? Those meetings are still on the Town Facebook page along with all comments and time stamped.

In my opinion what this really is is a group of residents who are looking for names to bully and attack and are frustrated they can't find any so I am again the target. This is pretty sad and a shame that I have to even wrote all this to have the public record accurate.
