Hi Tony - We sell our power to Constellation who was the high bidder this year. Revenue is \$50.74 per MWh. Total electrical revenues are estimated to be \$4.2MM for the year.

We carry no debt so there is no payment for any debt. If a municipality wants to leave, the agreement says that they shall turn over all assets including cash to the remaining member municipalities. I think it would be a mistake for a municipality to leave. Those that have considered leaving usually decide to stay after the review the financials and benefits from our regional approach. The one municipality that did leave is now wondering if they made the right decision. Maybe they will be back. Happy to discuss further. Please let me know if I'm missing any other questions that anyone has. Thanks, Kevin
