Forest Lake Association received a sum of \$14,000 for watershed protection in 2019. The money was used to repair high impact sites on Lakeside Drive in Windham that were identified in the watershed survey done by Forest Lake Association in 2017.

The entire funds were used to repair these high impact sites. The work was coordinated by Scott Campbell of the Lakeside Drive Road Association and completed by Storey Brothers. Windham engineer Mark Arietta was present for site reviews, planning, and site inspection after work was completed. Invoices, payments, and photographs accompany this report. Lakeside Drive Road Association met the matching funds for this grant.
