 RE: Growth Permit Summary Report Per Calander Year

By the Numbers for 2024 (as of 9/30/2024)

- 22 of 118 growth permits were issued to new single-family detached dwellings.
 - 15 of 45 (max Farm District total) growth permits were issued in the Farm District
- 11 of 14 (max two-family total) growth permits were issued to new two-family dwelling structures
- 38 of 135 growth permits were issued as of 9/30/2024
 - 135 is the maximum number of growth permit issued from Jan 1st to Dec 31st (pro-rated to 12 permits per month), the balance transferred to the reserve pool.
- 318 growth permits were transferred to the reserve pool since adoption of the ordinance (7-28-2020)

Note: The growth permits issued do not represent the actual number of dwelling units or structures built (certificate of occupancies issued) per Calander year.
