Hello,
My name is Jennifer Jimino. I am the proud owner of 10 Spirit meadow lane, where this "motocross park" is located.

I would like to first recognize that we do indeed have a dirt track in our backyard. But it is far from a motocross park. It was made for the kids to use their bicycles and dirt bikes on. I have a Kawasaki 140 this bike is quiet, Tucker has been using that for the last month and a half and that's the same bike as our neighbor with the two little girls has. They said that was fine and it's closer to Bills house than our track out behind my house.

Tucker who is a 9 year old boy, has a 50. Not modified.

This is his race bike and we track the hours on this bike. It is very common to have them on dirt bikes. He has less than 26 hours on this bike and he used it for last years motocross season. He did about 24 races last season. We have since sold that bike. We did use it a little here but nothing along the lines of what they are claiming. And that is the bike that you heard on the recording that Peter showed you at the town meeting.

My husband has a 450. This bike is loud. And too powerful to ride on out track. He may take a lap or two but it would be a total of 10 minutes. He rides up and down the driveway after doing maintenance (oil change, tire change) but besides that it's not used at home. And it is completely stock, zero modifications to the muffler.

My husband and I both work full time. Everyone is out by 7:45am and returns at 3:30 Monday through Friday.

We have three kids and they are all involved in sports. So they have practice sometimes till 7 at night at least two times a week. Then we have games that take up a lot of weekends. And we have motocross races on the weekends that take up a lot of time.

And to be completely honest, if any of us would like to ride our bike on our property for an hour or so after work we should be able to do so. There is nothing wrong with us riding. We do not ride before 8am and stop any riding around 7:30pm.

We did have a weekend where we were all home and we did more riding than normal but I assure you that it was within the decent hours I mentioned.

For the neighbors to say that we are out there all the time is a lie.

For them to say we have 10-12 bikes there is a lie.

For them to say we have multiple trucks and trailer here is a lie.

Peter has been having issues with us ever since we moved in.

He has threatened to flood our property by filling in the outlet on his end of the pond. He is now following through on that threat and dumping wheelbarrows full of dirt into the outlet. I have video to prove this.

I have called windham pd when this happened on Tuesday June 3rd.

He yells at the neighbors kids, swears at them and my husband, while my kids are playing basketball in our driveway. He has come over to our property several times while we are not home to snoop into what we are doing. He has crossed the line but yet we haven't called the cops, not till this last incident.

I understand that not everyone loves our "lifestyle" but that's not for my neighbors to dictate.

It may give him anxiety but that doesn't mean I can not enjoy my property that work hard for.
