New Rescue Units

Chief Libby returned from Ohio this week after a final inspection of the new ambulances. The units are now in Maine. The dealer is mounting equipment and lettering them. It is expected that we will have them for use within two weeks.

Extension of Moratorium on Retail Marijuana Establishments and Retail Marijuana Social Clubs

At its meeting on November 22, 2016 the Council approved an emergency ordinance imposing a 180-day moratorium on retail marijuana establishments in the Town of Windham. The Council subsequently adopted the ordinance on December 13, 2016 following a public hearing, keeping the moratorium in place through May 21, 2017.

The purpose of the moratorium was to allow the town time to identify issues raised by the possible location of retail marijuana establishments and put in place any policies or ordinances to address those issues. By law, the moratorium may be extended by additional periods of up to 180 days as long as the issues that gave rise to the need for the moratorium still exist and good faith efforts are being made to address those issues. A public hearing and vote have been scheduled for the April 25th Council meeting to extend the moratorium.
