Scheduling Notes.

A special meeting has been scheduled for January 9, 2016 at 9:00 a.m. for Council orientation and goal setting. The meeting is expected to last most of the day. A copy of the draft agenda is attached. Nearly all department heads will be able to attend for what we hope will be a productive day orienting and re-orienting the Council to the Charter and other fundamental documents and policies, providing brief mid-year budget and project updates, and assisting and supporting the Council in its goal-setting for 2016.

Report.

Wastewater Management Planning Advisory Committee.

The committee met with a team from Wright-Pierce on November 4, 2015 to develop an initial scope of work defining the questions to be answered and getting to a decision point on the type(s) of decentralized systems that might be used in combination with regulations to meet the town's wastewater management, ground water protection, and 21st Century Downtown development goals. That scope of work and fee estimate has been prepared and is planned for discussion with the Council at the meeting of January 12, 2016.

21st Century Downtown Preliminary Engineering.

TY Lin and MRLD have begun tasks related to preliminary engineering for improvements along Route 302. A discussion with the Council is planned for December 22, 2015 to address supplemental improvement issues such as storm water management improvements, signal upgrades, and the relocation of utilities underground.

Project/Issue Tracking.

More projects and issues have been added to the agenda items reports. Again, this is part of an effort to keep track of all the major things the Council and staff are working on. Regular updates of activity will be shown on the individual project or issue sheets. At various times they may be discussed in more detail here in the manager's report.
