RE: 2018 MMA Municipal Member Dues and Service Program

On behalf of the MMA Executive Committee and staff, I want to thank you for your support and participation in the Maine Municipal Association. MMA is your organization and we are committed to providing quality services and programs to all of our members.

In adopting MMA's 2018 budget, the Executive Committee continued to be mindful of the financial pressures facing our members. The Executive Committee and MMA management made a concerted effort to control costs while keeping intact the core services provided to our members and addressing some municipal challenges with new initiatives. The 2018 adopted budget calls for an average 1.00% increase in membership dues. The dues for each municipality will vary based on the MMA dues formula which was revised in 2013 to phase-in a realignment. The realignment addresses variances in property valuation and population among our members which had occurred over a number of years under the previous dues formula. The Executive Committee also approved a slightly more accelerated formula variance adjustment used to phase-in the realignment process for 2018.
