

TOWN OF WINDHAM, MAINE NOTICE TO CONTRACTORS

Sealed Bids addressed to Town of Windham and endorsed on the wrapper “Varney’s Bridge: Bids for Bridge replacement in the Town of **Windham**” will be received from contractors at the Town Hall, 8 School Rd, Windham, ME 04062 until 1:00 P.M. (prevailing time) on November 26, 2025. The bids will be publicly opened and read at 1:00 P.M. at the Windham Town Hall on November 26, 2025.

Description: Replacement of Varney Bridge in Windham, Maine.

Location: In Cumberland County, project is located over the Pleasant River in the Town of Windham, Maine on William Knight Road.

Outline of Work: The work to be done under this contract consists of the replacement of the existing bridge with a steel superstructure, concrete deck with concrete integral wearing surface, concrete abutments, replacing existing guardrails, approach work, and other incidental work.

Questions received after 12:00 noon of Wednesday prior to bid date will not be answered. Bidders shall not contact any other Town staff for clarification of Contract provisions, and the Town will not be responsible for any interpretations so obtained.

One copy of each Bid is required and must be made upon Contract Agreement Offer and Award forms provided by Town of Windham. Each Bid must be accompanied by a bid bond at 5% of the bid amount payable to Treasurer, Town of Windham as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.
