

## AGREEMENT

This Agreement made this \_\_\_\_ day of \_\_\_\_\_. 2017, by and between the TOWN OF WINDHAM, a municipal corporation, of the Town of Windham, County of Cumberland and State of Maine, and the TOWN OF GRAY, a municipal corporation, of the Town of Gray, County of Cumberland and State of Maine,

### WITNESSETH:

WHEREAS, the Town of Windham has contracted with Michael Sargent, doing business as Sumerian Irrigation, for winter maintenance on Mt. Hunger Shore Road; and

WHEREAS, a portion of said road is within the Town of Gray, but accessible only through Windham; and

WHEREAS, the Towns wish to share in the cost of said winter maintenance;

NOW THEREFORE, the parties agree to the following:

1. The Town of Gray agrees to pay the Town of Windham the sums set forth below during the initial term of this Agreement as a reimbursement for that portion of the Town of Windham's plowing contract covering the 0.464 miles of Mt. Hunger Shore Road in the Town of Gray:
  - a. for 2016-2017 the sum of \$2,180.80,
  - b. for 2017-2018 the sum of \$2,246.22,
  - c. for 2018-2019 the sum of \$2,313.61,
  - d. for 2019-2020 the sum of \$2,383.02, and
  - e. for 2020-2021 the sum of \$2,383.02.
2. The Town of Gray hereby affirms the existence of a public easement over that portion of the road in the Town of Gray and the authority of the Town of Gray to enter into this Agreement for winter maintenance of Mt. Hunger Shore Road. The Town of Gray further agrees that subject to the terms of the Maine Tort Claims Act and the obligations of Michael Sargent, doing business as Sumerian Irrigation, under the aforesaid snowplowing agreement, it will indemnify and hold harmless the Town of Windham for any liability for the plowing of Mt. Hunger Shore Road in Gray.
3. This Agreement shall be for a term of five (5) years, except that either party may terminate the same on six (6) months prior notice.
4. This Agreement shall be construed in accordance with the laws of the State of Maine and binding upon the parties hereto, their successors and assigns.
