Linda, I am in receipt of the liquor license application for the new owner of Windham Billiards, Sonje Swensen DOB 2-22-1965 resides at 147 Plummer Road Gorham, Maine. I have checked online investigative software we subscribe to, Sonje has no public records that would raise any concerns that I would have with her having a liquor license for her business. I have also checked her name in our inhouse system; I found no remarkable police contacts with Sonje who reports living in our region since 2009.

I will also mention that Sonje has proactively met with me to discuss her business plans; we have already established a dialog of how we would collaboratively handle any potential problems that may arise. Sonje told me that she has been employed at the current business Take a Break Billiards, for some time. I have queried our in-house system for calls for service for the past year at that location 824 Roosevelt Trail; we have had no remarkable incidents reported during this time frame.
