On behalf of Daigle Financial & Development LLC, we have prepared the enclosed application, plans and supporting material for Sketch Subdivision Plan Review of a proposed 4-lot residential subdivision to be developed as a Cluster Subdivision. The property is approximately 7.8 acres and is located in the Farm zone. The property is identified on the Town of Windham Tax Map 9 as lots 34, 34B1 & 34B2. The applicant currently owns tax lots 34B1 & 34B2 along with a portion of tax lot 34. A purchase and sale agreement has been signed for the applicant to purchase the remaining portion of tax lot 34 including the existing single-family dwelling.

The applicant is purchasing the existing homestead lot to better align the proposed roadway intersection to provide adequate sight distance. The house lot will be reconfigured as Lot 4 as shown on the attached plan as part of the Cluster Subdivision. The proposed roadway is intended to be constructed to the Minor Local Street standard to be offered for public acceptance.

The project does not propose any "bonus lots" as defined in the Cluster Subdivision Ordinance, and the open space is intended to be owned in common by a Homeowners Association comprised of the individual lot owners in the subdivision. Soils test pits have already been conducted on the property to demonstrate that suitable soils exist on each lot for septic systems.








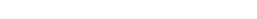
