

WARRANT
for
ANNUAL TOWN MEETING



TO: Constable, Town of Windham, County of Cumberland

GREETINGS: In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Windham in said County, qualified by the law to vote in Town affairs, to meet at the Community Center Gym, 8 School Road in said Town, Saturday, June 15, 2019 at 9:45 in the forenoon and there to act on the following article:

ARTICLE 1: To elect a moderator to preside at said meeting.

Furthermore, you are required to notify and warn said voters to meet at the Community Center Gym, 8 School Road in said Town, Saturday, June 15, 2019 at 10:00 in the forenoon and then to act on several remaining articles in the warrant. All the said articles being set forth below, to wit:

***Reference Note:** If Articles 2 through 7 are approved as recommended by the Windham Town Council, the amount raised by local property tax for municipal services will be \$10,150,520 for fiscal year 2019-2020.*

ARTICLE 2: Shall the Town vote to apply \$3,950,000 of anticipated excise tax receipts against the fiscal year 2019-2020 total Municipal Budget as approved by the Windham Town Council?

ARTICLE 3: Shall the Town vote to apply up to \$249,899 in recreation program fees against the operations of the Recreation Program Fund during fiscal year 2019-2020 as approved by the Windham Town Council?

ARTICLE 4: Shall the Town vote to apply up to \$381,439 in user fees against the operations of the Sewer Fund during fiscal year 2019-2020 as approved by the Windham Town Council?

ARTICLE 5: Shall the Town vote to accept and apply \$8,592,548 of miscellaneous revenues including Local Road Assistance; Boat, Snowmobile, and ATV Registration Fees, Homestead Exemption Reimbursement, Tree Growth Reimbursement, General

Assistance Reimbursement, Veteran's Exemption Reimbursement, and any State grants or other funds as anticipated to be provided by the Maine State Legislature against the total Municipal Budget for fiscal year 2019-2020 as approved by the Windham Town Council?

ARTICLE 6: Shall the Town vote to apply \$1,791,451 of unappropriated funds from Town Fund Balance against the Municipal Budget for fiscal year 2019-2020 as approved by the Windham Town Council?

ARTICLE 7: Shall the Town vote to authorize a total Municipal Budget for fiscal year 2019-2020 of \$24,484,519 as approved by the Windham Town Council?

***Reference Note:** Articles 8 through 18 shall be voted on only if Article 7 is not approved.*

ARTICLE 8: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$4,738,045 for General Government as approved by the Windham Town Council?

ARTICLE 9: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$3,976,219 for Public Works Services as approved by the Windham Town Council?

ARTICLE 10: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$2,963,633 for Police Services as approved by the Windham Town Council?

ARTICLE 11: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$2,258,538 for Fire/Rescue Services as approved by the Windham Town Council?

ARTICLE 12: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$890,867 for Recreation and Cultural Services as approved by the Windham Town Council?

ARTICLE 13: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$721,312 for Property and Inspection Services as approved by the Windham Town Council?

ARTICLE 14: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$593,859 for Development and Conservation Services as approved by the Windham Town Council?

ARTICLE 15: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$227,373 for Health and Welfare as approved by the Windham Town Council?

ARTICLE 16: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$8,094,673 for Capital, Debt, and Other Charges as approved by the Windham Town Council?

ARTICLE 17: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$249,899 for the Recreation Program Fund as approved by the Windham Town Council?

ARTICLE 18: Shall the Town vote to authorize a budget for fiscal year 2019-2020 of \$381,439 for the Sewer Fund as approved by the Windham Town Council?
