Dennis Marotte from Westbrook invited everyone to the Windham Library on Tuesday, May 7 from 4:00 to 5:30 for the opening of the Bridges of Friendship photo exhibit. November 17, 2018 marked the 30th Anniversary of the Sister City Relationship between the Greater Portland Region, Maine and Archangel, Russia. This is a photographic cultural exchange between the Portland Camera Club of Maine and the Spolokhi Photo Club of archangel, Russia. Mr. Marotte also passed around some photos he had brought with him.

Ken Cianchette, owner of Erik's Church, came to address the issue of emails he saw with the Chair of the Planning Board last month about how he is upset with the amount of traffic going to Mr. Clanchette's site and feels something needs to be done about that.

Dennis Brown - Most of the language in the ordinance has been judged by people who have a lot more expertise than him, and they seem to think this was very well done and should set the standard for other communities around the state.

Also noted that there is one part that was raised at the previous meeting in section 606 addressing the housing density on private roads, and whether it should be a 100 houses and whether having a number on the road is an appropriate to use? He does not feel this is a reasonable method of determining whether mineral extraction should go into an area. Mr. Brown encouraged them to look hard at the zoning.

Kevin Clark James Way - Zoning is a large factor but did not want to downplay the importance of what has been put together and they should still vote for the ordinance tonight to take place.

Ann Spurling James Way is grateful that they all have been able to talk about what they think is best for the town and the Council has listened.

X. Town Manager's Report.

Don Gerrish:

Hoping to have the Public Work's Open House the first week in June. Council agreed to meet and take a tour of the new facility before a Tuesday night meeting.

Acceptance of applications for Town Manager ended this evening. They have received a fair amount, and the Council will receive them on Friday. Don said they will meet at 6:00 p.m. on Tuesday to discuss them.

In regard to the workshop on trash bags and signing the contract; Don got a response from the company and sent it out to everybody. They answered his questions about the thickness and other issues, and they will take back any bags that rip or we have problems with.

They signed a contract today for Phase 1 of Brand Road - they actually got two bids for

Phase 1 and Phase 2. They will have to wait to sign for the phase 2 budget until they have some money, hopefully in next year's budget. They had anticipated \$1.3 million to do both and the total price to do 1 & 2 is \$1,057,000.
