## **Cultivation for Personal Use**

- ☐ Allow per state law (can be on property where user domiciled, other property owned by user, or on other land by agreement)
- ☐ Allow only on land where user is domiciled
- ☐ Limit number of mature plants allowed? (Must allow for at least 3 adult plants, 12 immature plants and unlimited seedlings for each person domiciled on the property).
