As I stated in my phone message to you in regard to the Angler's Road Commons Apartments project in Windham, the Town of Windham is looking for some confirmation from MDEP that the Stormwater Permit L-27715-NB-A-N authorizes the elimination of the infiltration basin that currently exists on the property that was constructed as a required BMP for the Stormwater Permit issued to the Town of Windham in 2014 (I do not have the permit order #). Section H of our submitted Stormwater Report called attention to this matter, but it was not referenced anywhere in the Permit Order, so the Town is just looking for some confirmation from MDEP that they are authorizing Anglers Road Commons, LLC to be responsible for the developed areas that were constructed as part of Angler's Road that are currently being treated using the infiltration basin that is proposed to be removed under the new permit order.

Please let me know if you have any questions or if you need any additional information. I think an email response will be sufficient, or a letter on MDEP letterhead would be even better. We need to provide this to the Town by Tuesday, June 18<sup>th</sup>.
