Summary

It is the mission of Social Services to improve the quality of life for people in need¹ who reside in the Town of Windham, by:

- Promoting economic self-sufficiency; and
- Connecting people with those resources made available by the Town, the state and the federal government, in accordance with applicable laws and regulations.

Each month the current status of the program will be assessed using the following measures identified in the budget narrative.

1. People in need are counseled and provided information and referrals regarding local, regional, state and federal social service programs.

- a. In May, as in previous months, we coordinated with government and community based agencies that offer resources to strengthen individuals and families and promote economic self-sufficiency, such as Project Feed, USDA, DHHS Emergency Funds, and the Aspire Program. We also coordinated with other providers of social services, such as the Good Shepherd Mobile pantry, Opportunity Alliance which administers LIHEAP; RTP Bus Service, Salvation Army and Neighbors Helping Neighbors.
- b. Social Services made/received six hundred and forty-two (642) phone calls²; interviewed fifty-nine (59) individuals for direct general assistance³, and provided food/non-food assistance to three hundred and forty-five (345) households. Each individual was provided education and information regarding additional resources available to them and encouraged to investigate these programs, and in many cases received assistance from staff (phone calls, emails, etc.) to connect with these services.

2. People in need that qualify for General Assistance under the Ordinance receive temporary assistance for basic needs.

- a. In May, three hundred and forty-five (345) households in need were assisted by the Food Pantry and/or the Clothes Closet.

¹ “People in need” are defined to include those people who qualify for financial or other assistance according to regulations issued by the Town, the state and the federal government. As authorized by the Town, Social Services may offer additional services to enhance the quality of life for children, families and seniors.

² This number includes calls from those seeking food/non-food, clothing, and/or financial assistance, out-reach to the community and calls made on behalf of clients seeking assistance.

- b. Vouchers are provided for housing, winter emergency fuel, or electrical assistance to those who qualify for it, under applicable law⁴. All decisions are rendered within twenty-four (24) hours as required by the state. In May four (4) Windham residents qualified for direct general assistance.
- c. Staff continued to reach out to members of the community, local businesses and NGO's that support with their time and their donations. In May, the Food Pantry received \$ 3,175.00 in donations and sixty-four (64) community members volunteered on hundred and twenty-one (121) hours of their time.

3. The annual audit demonstrates compliance with state regulations.

- a. An annual audit was conducted in in March of 2019 by the Department of Health and Human Services (DHHS) Field Examiner, Gerry Biron, and he noted 100% compliance in all areas.

All of the programs located at the Family Resource Center, support the mission of Social Services and all of those that sought assistance in May received some type of assistance – food/non-food, educational/informational, or financial⁵.

As a result of these efforts, and the generosity of so many groups and individuals, assistance was provided to almost hundred (400) eligible individuals and their families while working to help them to achieve improved self-sufficiency.

Highlights

- Fifteen Food Pantry/Clothes Closet volunteers attended the annual volunteer “thank you” from the Town. This year it was held at St. Joesph’s College. They all appreciated the wonderful meal.
- Social Services staff wrapped up the interviews for summer camp scholarships. In all, over fifty (50) families applied and were interviewed.
- Volunteers, Ann Atherton and Cheryl Mannette volunteered for the messy duty of sorting through Hannaford egg donations. They were able to salvage fifty-three (53) dozen eggs that were warmly welcomed by Food Pantry clients.
- Jacob Piechowski (Employee, Liz Sheetz’ son) volunteered (again) giving two days of his time to help to sort through and reorganize the can goods. His help is always valued and appreciated!
- The Windham Little League held a second food drive and brought in five hundred and nineteen (519) food items and twenty-four (24) personal items for Food Pantry clients. Many thanks for their hard work!
- The American Legion in Windham held their annual food drive to benefit the Food Pantry. They brought in over two hundred (200) pounds of food items and a generous donation of \$1500.00. We so much appreciate all that they do!
- All clients were encouraged and reminded to come to the Food Pantry each week, in addition to their monthly visits for fresh fruit, vegetables, bread and pastries.

Statistics

- Two hundred and sixty-seven (267) households were served through the Food Pantry; four (4) were new clients.
- Sixty-four (64) volunteers worked a total of one hundred and twenty-one (121) hours in the Food Pantry and Clothes Closet.
- The Food Pantry received/made three hundred and forty-five (345) phone calls.
- The Clothes Closet received twenty-nine (29) donations (multiple boxes/bags) of clothing and linens and served seventy-eight (78) households.
- The Food Pantry received thirty-five (35) donations from residents and fresh fruit, vegetables, baked goods, meat, and bread bi-weekly from Hannaford in Windham.
- Twelve (12) thank you notes and/or receipts were sent to residents for their donations.
- General Assistance received/made two hundred and ninety-seven (297) phone calls⁶.
- Fifty-nine (59) individuals were interviewed for direct general assistance: Forty (40) Windham; nineteen (19) Gorham.
- In May, four (4) Windham residents qualified for direct general assistance; and one (1) Gorham resident qualified for direct general assistance.

Type of Assistance Requested	Assistance Provided
12 requests for housing assistance	4 were provided financial assistance for rent; all others were referred to Westbrook Housing Authority for Section 8 or Senior Housing.
22 requests for assistance with gas/electrical/water and home repair bills	0 were provided financial assistance; all were referred to DHHS, LIHEAP, the Salvation Army as well as being assisted in signing up for Efficiency Maine/Electricity Maine.
4 requests for food/non-food/clothing assistance	All were serviced through the Food Pantry and Clothes Closet.
2 requests for emergency fuel	0 were provided financial assistance; all were referred to DHHS, LIHEAP, NHN, the Salvation Army as well as being assisted in signing up for Efficiency Maine/Electricity Maine.
