Interim Town Manager Gerrish said this is the same issue they had at the May meeting. This is part of a sub-division that they are now looking at as being an illegal sub-division,

and the Town Attorney and the Code Officers are working on it. The owners want to sell this parcel, and they are not the original owners of the parcel. They bought it from the original owner and they have no legal rights to go back against the developer. The attorneys have met and they are recommending the town do the same consent agreement as before.
