Re: Assigned Fund Balance

Attached is the FY 20 Assigned Fund Balance report - also known as the Carry Forward Accounts. Actual definition is: "Amounts that are constrained by the government's intent to be used for specific purposes, but that are neither restricted nor committed (excluding stabilization arrangements)".

This must be approved by the Town Council each Fiscal Year.

Council consent authorizes us to add the various balances as Adjusted or Revised Budget amounts, allowing the use of the funds during the FY 21 budget year.

Once this has been approved by the Town Council it will be shared with RKO and will be part of the Fund Balance detail notes in the FY20 Audit report.
