Hi, Chuck. The prior owner's old permit is not transferrable, so the new owner will need to get a new permit. Section 3754-A does require the junkyard to show at the time of application that it is part of a viable business entity and that the applicant is "actively engaged" in salvage work at the time of licensure. I do not consider moving tires around to be active engagement. There has to be a real business plan involving dismantling and reselling the parts. I would suggest requiring the new owner to submit a permit application and demonstrate proof that the activities are part of a real business. One option could be to require ongoing proof at three or six-month intervals demonstrating that they are deriving income from any salvage or sales.

Another is the transferring of permit, I believe that I'm right in saying that the permit is not being transferred but instead a new permit is being issued for an existing junkyard. Lastly, section 3754-A-5-D states that the yard has to be "actively engaged in the business of", there has been many tires left by the previous owner that the current owner in now removing, not sure if that counts.
