*Councilor Nadeau asked Gretchen how many applications did we receive?. She said there were three applications.*

*He asked what are they putting in for in-kind? Gretchen said a 50% match is the requirement and 25% of the 50% has to be cash.*

*Councilor Kalogerakis asked if the milfoil ever going to get totally removed? Gretchen said milfoil is extremely hard to get rid of and this is our best removal process outside of*
