VIII. UNFINISHED BUSINESS & GENERAL ORDERS.

To authorize the borrowing of an amount not to exceed \$4,960,554 by the Town of Windham (the "Town") by the issuance of one or more general obligation bonds, which general obligation bonds will pay all or a portion of the costs of the design, construction, improvement, expansion, repair and equipping of the police and fire station located at 375 Gray Road and related development of the site; repair of sidewalks on Route 35; repair, improvement and repaying of portions of Brand Road; design, acquisition, installation, upgrade, improvement and maintenance of traffic lights; and the acquisition of an ambulance, dump truck and pickup truck; and costs of issuance of the bonds, with the details of such borrowing determined by the Council.

For the Council's reference, Moors & Cabot, Inc. is acting as the Town's municipal advisor for the issuance of the bonds.

Manager Tibbetts said at the annual Town Meeting in June the Legislative body authorized this bond to be issued, and this is the second step of that process where the Council has to authorize, by Order, the issuance of these bonds. They are using Moors and Cabot out of Boston.

Barry said they had to put an upper limit on the interest. Barry explained that they are issued out into the market and once they have been issued into the market, different institutions will put a place holder in to purchase those bonds; they might come in a 1% or 1.25%. Joe Couture collects all that data, and he will call the town's Treasurer and the Chairman of the Board and will ask if these are acceptable rates. This usually happens in January and it will take 4-5 weeks putting together the bond issue booklet, which goes out to perspective purchasers to view. Barry said a recent one that Joe was involved in was for .95%, which is really great.

Councilor Nangle asked why the interest limit is at 4% when they expect a much lower rate? Barry said they had to pick a worse case scenario range and that was the recommendation from our Bonding Agent. He said it is typical to go a couple of points higher so there is no hiccups in the process. Councilor Nangle said everything the Council said throughout was that we were going to be at probably at 2% or less, and that is the presentation they made to the public, it was discussed in open meetings, and not where we are at 4%.

The Manager said these bonds will be issued in January, it is the best time to issue bonds, it is when they are the lowest. He also checked the original warrant to see what interest rate was put in and it was 2.25%. Councilor Nangle asked why, then, wasn't it 2.25%? The Manager said that was a recommendation from Joe, our Bonding Agent. He said they do not have to accept them if it is at a higher rate, we can say no.

Councilor Maxfield moved to amend Order 20-152 to say if the bond rate comes back to the Manager and Council Chair higher than 2.25% it will be sent back to the Council for approval, second by Councilor Kalogerakis.
