Malina Dumas a resident of Windham and works at the Law Firm Drummond Woodsum. and they represent Andrew Keeley who is the owner of the Caregiver Retail Store Alternative Essence.

She apologized for trying to speak earlier she was worried she might miss her chance to speak. She saw there was a new agenda posted that includes a memo from Attorney Collins that frames this as an extension of a suspension of use of the Adult Use Marijuana Store License. The Licensees actually needed to submit a written request under the ordinance within the first 6 months of licensure. Then the Town Council could have voted within that time frame to include an extension of that suspension of use for up to one year. She said it does not seem, from the agenda packet or any of the materials provided, that such a written request was made within that time frame. Renovation is a grounds that is enumerated in the ordinance for a written request to be made to the Town Council to approve a suspension of use. You can't approve that extension after the one year period has elapsed.

She said the memo provided tonight also indicates that you should seek construction as an active use of the licensed premise but you cannot have it both ways. Either you are asking for a suspension of use of the license because you are renovating and undergoing construction or you're saying that this is an active use of the license to engage in construction on site. Ms. Dumas said the problem with the later is that there is another provision under Section 167 K 2 that says you forfeit your license if you make an active use of the licensed premise. That's not under the license itself, so if these stores currently are operating as Caregiver Retail Stores, which she believes they are, that would be the active use of the licensed premise. The licensed premise as defined in the ordinance is the premise that they've outlined in their application. So under subsection 2 if you are saying that construction is an active use of the premise then you would also concede that operating a different licensed entity, are Caregiver Retail Store selling Medical Marijuana is a different business than an Adult Use Marijuana Store selling Adult Use Marijuana, and therefore the licenses would have been forfeited under that other provision. Her interpretation of the ordinance is that these licenses have already been forfeited in one of two ways, and possibly both.

Their client would request, that instead of granting these extensions under the terms of the ordinance, the Town Council open up the application period again. There have been a number of businesses who have been on the wait list for a year. She said she thinks they made a policy decision to include these forfeiture provisions including for licenses that were part of a competitive licensing process. She hopes the Council will consider the fairness to those that waited for a year on that wait list, because it appears now that the intent may be to allow extensions indefinitely, and if they are not open by April 2022 they will come before the Council again and get another extension.

She wants them to think about the provisions of the ordinance that are impacted by a decision tonight and that would instruct your decision on this matter. She thanked the Council.

Councilor Nadeau moved to amend the motion to say: Motion to find that (1) Adult Use Marijuana Retail Store licenses issued to Jar Co. and Paul's Boutique in 2020 were properly and timely renewed for the 2021-2022 year; (2) each license holder has made active use of its respective licensed premises by actively pursuing construction needed to open the Adult Use Marijuana Retail Store Use; (3) that each license holder has experienced unforeseen delays due to labor and materials shortages related to the COVID-19 pandemic; (4) as such, the licenses for Jar Co. and Paul's Boutique are not deemed to have been forfeited pursuant to Section 160-7 (K) of the Marijuana Business Licensing Ordinance; and (5) to the extent required under Section 160-7 (K) the two license holders shall be given until April 1, 2022 to open their respective Adult Use Marijuana Retail Stores and, if opening shall not occur by that date, shall appear before the Council for further consideration pursuant to Section 160-7(K), second by Council Maxfield.
